 - b. Complete the entries of registration form.
 - c. Visit ANTI-RAGGING Website (http://antiragging.in/Site/Affidavits_Registration.aspx), upload the details and take its print-out. Duly signed hard-copy (signed by both – student and parent) is to be submitted alongwith the registration form.
 - d. Duly completed and signed hard-copy of registration form along with Anti-ragging affidavit (downloaded from Anti-ragging website) is to be submitted to the respective class-counsellor on the notified date. Collect the counter foil of the registration form from respective class-counselor.
4. In absentia and without valid Identity Card, the registration cannot be done.
5. Without completing the registration (whatever be the reason), concerned student will not be permitted to attend the classes.
6. Attendance will be counted wef commencement of classes (irrespective of date of registration). Attendance rules – as per the affiliating university – shall be applicable.
7. A late fine of Rs 100/- per day will be applicable on late registration (on or after the notified date), whatever be the reason.
8. Courses selected at the time of registration (dept. elective and / or open elective, as applicable) shall be treated as final and cannot be changed during entire semester, owing to any reason
