- 2. Fee (in full with all dues) is to be paid prior to registration.
- 3. Mentioning complete and correct information of ABC ID and Anti-ragging Reference is mandatory.
- 4. Registration Form has been emailed to all the students. The same is also available with class-counselor / MIET Website (download section).
- 5. Students having AKTU End Sem Exam of Odd Sem : 2023-24 will be exempted from attending the regular classes of Even Sem : 2023-24 on all concered days (days on which exam is to be conducted).
- 6. For completing the registration, students are required to:
 - a. Pay full fee with all applicable dues and produce its receipt at the time of registration.
 - b. Complete the entries of registration form.
 - c. Visit ANTI-RAGGING Website (https://antiragging.in/affidavit affiliated_form.php), upload the details and save its PDF copy. Take printout of Anti-ragging reference number and mention it in the registration form.
 - d. Submit duly completed and signed hard-copy of registration form along with Anti-ragging affidavit (downloaded from Anti-ragging website) to the respective class-counsellor on the notifed date.
 - e. Collect the counter foil of the registration form from respective class-counselor.
- 7. In absentia and without valid Identity Card, the registration cannot be done.
- 8. Without completing the registration (whatever be the reason), concerned student will not be permitted to attend the classes.
- 9. Attendance will be counted wef commencement of classes (irrespective of date of registration). Attendance rules as per the affiliating university shall be applicable.
- 10. A late fee of Rs 100/- per day (maximum of Rs 8,000/-) will be applicable on late payment of full fee with dues (on or after the notified date), whatever be the reason.
- 11. Courses selected at the time of registration (dept. elective and / or open elective, as applicable) shall be treated as final and cannot be changed during entire semester, owing to any reason
